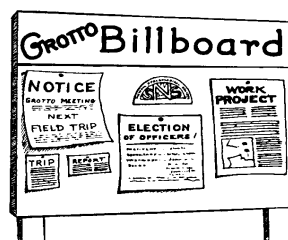

Fall VAR, October 21-23, 2022, was held at the RASS property in Bath Co., VA.

180 people attended. It did not rain. The night sky was incredible, with planets, the Milky Way, and a promise of meteor showers. (Forget the meteors – it was too cold!!!)

Bone Cave Trip Report

10/8/2022: Participants included Susan Burr, Doug Feller, Kelly Perkins, Jeff Huffman, Nick Schmalenberger, and Lauren Appel.

Note we had to change the date of our grotto weekend to accommodate several cavers.

We originally planned on going to **Norman Cave** since we figured the water levels were low. On the way Doug asked if we wanted to pop into **Bone Cave** first. Since none of us other than Doug had been there, we said yes. The plan now was to go to Bone first and because we thought it was a small cave, we figured we would head over to Norman afterwards. Well, the best laid plans change sometimes.

We did manage to find the Bone Cave parking area. When we arrived another group or two were there. Doug kind of confirmed the direction we needed to go to find the entrance with someone in the group. We headed out and basically found the entrance with no problem...so we thought.

We got into the cave, and we were not very far in when it appeared to just end. Both Jeff and Doug were climbing up to check out some of the higher areas for leads. None were found so we thought we possibly had gone into a small insignificant cave. We headed back out and

started exploring along the quarry wall. We did find another small cave, but determined it was not it, so the search continued. Meanwhile we noticed the other group was heading to the first cave entrance we went in. We headed back up and found out we were at the Bone Cave entrance originally. We followed them into the cave and discovered in the area we turned around at, we never really got down low, which had tight belly crawl to continue.

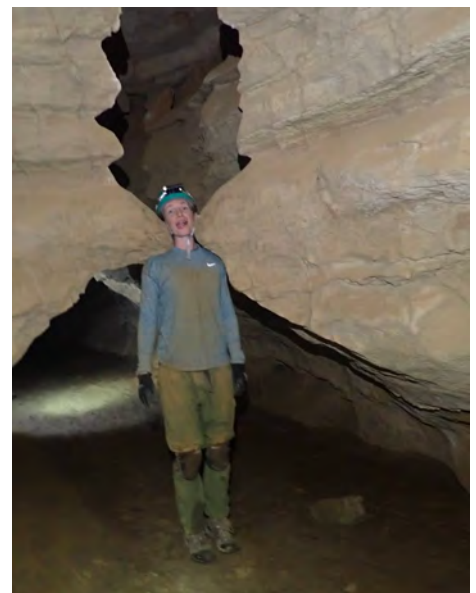
We occasionally got to an area with a tight belly crawl, and we weren't sure if we should continue or not. We basically wanted to go to see the connection between Bone and Norman Cave. Luckily, the other group caught up with us and let us know we needed to continue and where to look for the turn off to go to the connection passage.

At one of the tight belly crawls, which we thought was to the connection, it appeared to be really long. Since I have had back issues, I decided I shouldn't go. Nick, I believe, was also tired or over the belly crawling, so we decided to hang out until the rest of the group returned. While we were waiting, the other group came and told us that was not the passage to the connection, it just continued into the cave. Because of this info, Nick and I continued. Nick and I eventually got to a section where a single caver/spelunker was sitting. He was waiting for his group to come out of the passage to the connection. This is where Nick and I decided to sit and wait. Eventually the other guy's group came out and they were definitely not properly attired cavers.

Since the walking passage seemed to continue, I decided I wanted to go ahead and check out the rest of the cave while we were waiting. Nick decided he would come as well. We left our cave packs at that intersection in case the group came out before we returned. I figured they would realize we were close by. The back of the cave was not too much further. We checked out the back room and then, on the way back to the junction, we decided to climb up a rope we saw. This took us to an upper section we explored. Afterwards we headed back to meet the group.

Once we reunited with our group, it was decided we needed to head out since we were going to go to **Norman Cave** next. It didn't take long to determine we would not have enough time to go to Norman's, so we just took our time getting out and checking out all the areas.

Despite not really having a clue about Bone Cave, other than what Doug could remember from MANY years ago, we did pretty well. I now know that there are LOTS of belly crawls to continue through the cave. Unfortunately, Nick and I did not get to see the connection of the two caves, but the others did. I believe they also went through the connection to see if they could make it. At least now we know we could do a through trip if we wanted to in the future! 🐉

Grotto Trip Log

10/1 – 10/8: Fort Stanton Cave, NM. On 10/1 the participants included David Socky, Garrett Jorgensen, Karla Zajac, Minori Yoshida, Michael Moffit, and Ron Lipinski. We went to the Lincoln Caverns section of Fort Stanton where Garrett handled a \$40K *GeoSlam lidar unit* to obtain a detailed mapping of this section of the cave. I took lots of videos with the help of Karla. We also helped Michael Moffit and Ron Lipinski do photogrammetry – a method of obtaining 3-D imagery of the cave.

On 10/2 the participants included David Socky, Ron Lipinski, Pete Lindsley, and Alex Fischer. The first part of the day was with Ron, Alex, and I where we did a precision vertical survey from the top of 12 Steps into Crystal Crawl. We used a long plastic tube to measure vertical difference between stations to the precision of millimeters. The second half of the day Alex, Pete, and I went to the ladders before the dig shaft to repair the lower ladder. Then, while Pete worked on rusty bolts in the dig shaft, Alex and I went down to Snowy River at Turtle Junction. We confirmed that the was water flowing in Snowy River. Alex and I also checked out the Don Sawyer Memorial Passage just before the Dig Shaft.

Then on 10/4 & 10/7 the participants included David Socky, John Lyles, and Linda Star. On the surface was Blaze Cunningham, Seve Peerman, and Wayne Walker. John Lyles tested a high frequency radio system which sends text messages using cell phones. The first day we had to abort halfway through the test because of a thunder storm. The radio system worked with

an overburden of about 200 feet, but at spot where it was greater the 300 feet, the radio signal did not make it through.

Then on 10/8 the participants included David Socky, Jennine Smith, Scott Christenson and Jake Collison. We helped Scott Christenson and Jake Collison check batteries and data for evaporation stations at Inscription Hall and at Turtle Junction – the intersection to Snowy River. Jake was the main guy who devised and constructed the evaporation stations. Scott is the geologist who is helping with the studies.

10/6: Cactus Cave, NM. Participants included John Moses, Sam Bono, and Dave Socky. Went to Cactus Cave to retrieve tools at the dig. Only saw about 40 feet of cave, including the dig face. One of the other abandoned digs went a bit further, but apparently it was real gnarly.

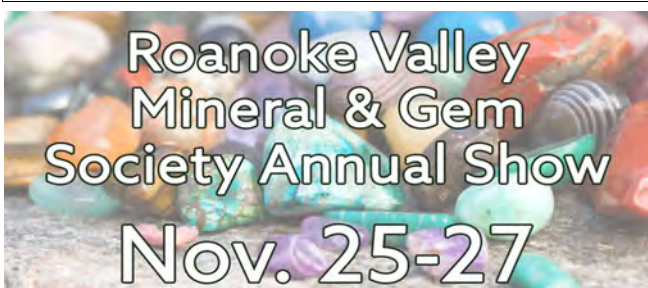
10/19: McClungs Cave, WV. Participants included David Socky, Joe Zokaites, Bob Alderson, and Bill Koerschner. We did the bolt climb near the start of Musser's Mess. It didn't go. Then Bob did the traverse using nails at the start of Bat Bone Crawl. It didn't go either. Bob slipped trying to change feet on a nail, but Joe as belayer, caught him. He was also attached to another nail plus his etrier caught another nail, so he only slipped a foot or so. But it was still an adrenaline rush for Bob. We surveyed 123 feet of new cave on the 7.5-hour trip.

10/22: Wishing Well Cave, VA. Participants included David Socky, Bill Koerschner, Shawn Hogbin, Neil DeJarnette, Mike Lacey, Eric Collins, and Tyler Wieckert. I led this trip into Wishing Well Cave for Fall VAR 2022. I had Bill and Shawn to help because they

wanted to go on this trip. Tyler was a young kid who had never been on a wild cave trip before. He did great and really enjoyed himself. Eric Collins was a British caver who had never caved in the US before. Neil hadn't caved for 15 years and admitted to not being in shape for the crawls. We made it back to Echo Junction and only made two wrong turns on the way out. There was a lot more crawling than I remembered. Even in Sugar Run - half of that was crawling. However, there were two really cool and really long lift tubes in Sugar run. We made it back to VAR in time for dinner after a fun 7-hour trip.

10/26: McClungs Cave, WV. Participants included David Socky, Joe Zokaites, and Bill Koerschner. We cleaned up leads at the turn off from Megalithia for Outer Mongolia. Our original goal was Outer Mongolia, but never made it there because it took a lot longer to do mop up. We did get 35 stations, mostly pretty short shots, resulting in only 336 feet of survey on an 11-hour trip.

10/29: McClungs Cave, WV. Participants included David Socky and Joe Zokaites with a second team of Nikki Fox, Carl Amundson, and Paul Walko. We went into Lightner entrance and surveyed in the Third Breakdown. Joe and I did mostly crawly side passages except for the connection back up to the WFD survey. Nikki and team did the main way on. There was lots of crawling. Third Breakdown is not huge height-wise. Some of the stuff Nikki did was really wide, but low. Overall, it was a good trip. We surveyed a total of 1090 feet on a long 13.5-hour trip. 🐾

New River Cave Preserve

Hello VAR members,

Let me introduce myself if you haven't met me, my name is Travis Coad. I have been caving in the New River Valley for the last 20+ years, I am member of VPI Cave Club, a founding member of the Blacksburg Cave Rescue Group, and also the Outdoor Supervisor for Town of Blacksburg Parks & Recreation.

I want to reach out to the VAR membership and as you may or may not know that in 2021, I was appointed the New River Cave Preserve manager for the NSS. I would appreciate an email to newriverpreserve@caves.org if you or your organization plans to visit New River Cave. Please include your organization name, date of visit, and number of people in your group so I and the NSS can keep some statistics on visitation to the cave. Also remember to sign the registers at the Kiosk and in the cave. (Friendly reminder and please spread the word the register at the Kiosk is NOT a sign out and should not be treated as such.)

I am also asking you and your organization to be additional eyes and ears on the preserve property. Please feel free to contact me at newriverpreserve@caves.org with any updates, issues, or interesting things going on at the preserve and I will look into them.

Things to keep in mind for your visit.

- Oct 15 through April 15 is when the bats are hibernating in the cave. Cavers should move quietly and quickly through the front of the cave to when you break into the main cave, a couple hundred feet past the register room. Take care not to touch or linger near bats. The area where little browns roost in planetarium/attic should be avoided during this time. The bats appreciate it.

If there is anything (within reason) that you think would make the preserve better for everyone please send me an email and I will see if it fits within the scope of preserve management plan.

Additionally, I would love it if you would be involved with the management of the NRC preserve. After all this is everyone's cave. Tasks could include but are not limited to site visits, trail maintenance, scheduling and organization of workdays, fundraising, grant writing, conservation trips, data collection, and more. If any of your membership would be interested, please email newriverpreserve@caves.org.

2022 ELECTION INFORMATION

The November meeting is always extremely busy and well attended, 'cause November 18 is the evening BRG officers are elected for the next year. Whether you want to run for office or railroad your caving buddies, a few basic rules must be followed, as described in the BRG constitution & bylaws:

- 1) **Voting** - in order to vote, you must be an active (paid up) NSS member *and* a BRG member: aka Regular or Regular Family grotto member status.
- 2) **Candidates** - to be an eligible candidate for office, you must be an active NSS member AND have been a BRG member for at least one year.
- 3) **Term of Office** - for one year, ending in November. No officer can hold the same office for more than two years in a row. Elected officers are expected to attend all meetings, or be impeached and executed by the grotto.
